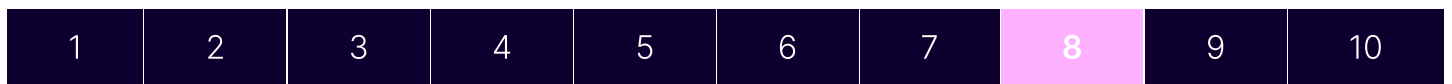
Risk and Reward Profile

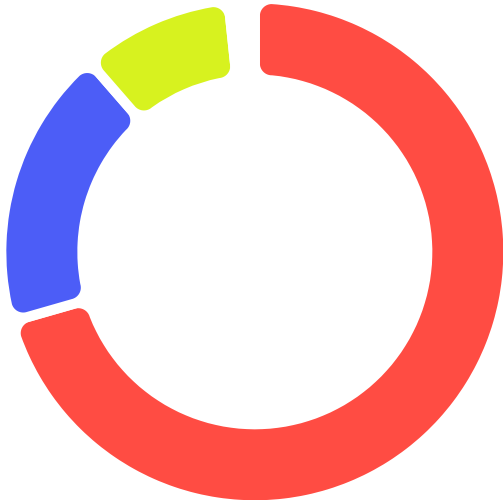
