## Portfolio Strategy

Octopus Money Passive portfolio range is an investment solution that adopts a diversified approach to asset allocation and invests in predominantly passive funds. The solution offers a complete range of risk graded portfolios from 1 to 10, all well diversified across the major geographies and asset classes. The portfolios have been designed to track the performance of the world's major stock markets. Asset classes and their weightings are reviewed annually to make sure the risk and return profile of each Risk Grade remains optimal. This portfolio is allocated 30% to equity and 70% to fixed income. We'd expect this portfolio to have lower levels of volatility.

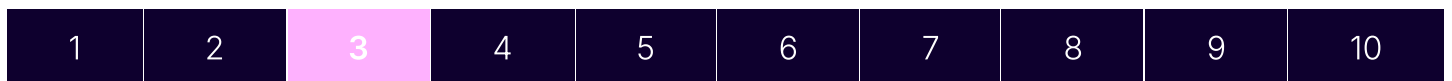
## Risk and Reward Profile

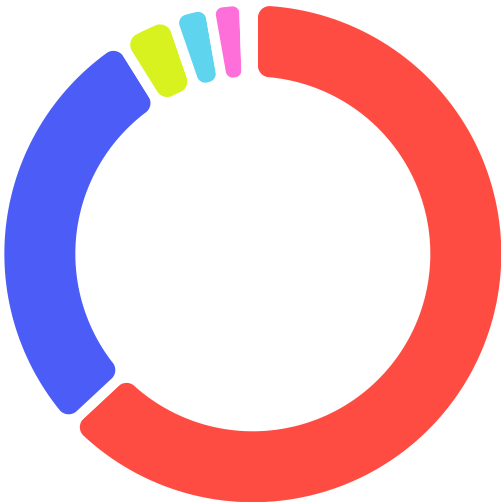

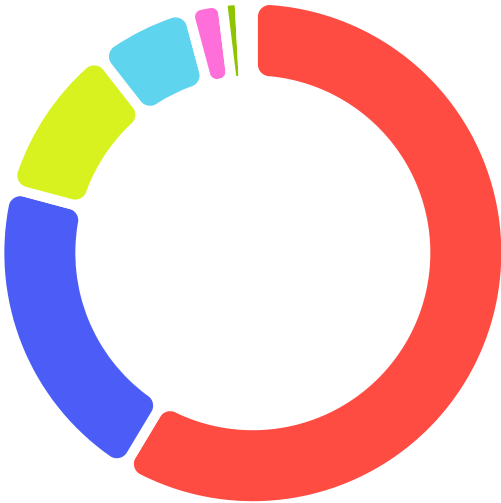
